

Inside American Funds® IS 2015 Target Date Fund

The target allocations are as of most recent prospectus, and are subject to the Target Date Solutions Committee's discretion. The funds' investment adviser anticipates that the funds will invest their assets within a range that deviates no more than 10% above or below these allocations. Underlying funds may be added or removed during the year. Changes in the equity allocation within the underlying equity-income and balanced funds may affect the overall equity exposure in the target date funds. Intermediate Bond Fund of America

- The fund's investment objective is to provide you with current income consistent with the maturity and quality standards described in the prospectus and preservation of capital.
- Balancing income and preservation, this limited-term bond strategy seeks to reduce interest rate risk and diversify equity exposure by holding only investment-grade (rated Baa/BBB and above), dollar-denominated bonds in a portfolio with a dollarweighted average effective maturity between three and five years.
- Primarily invests in corporate bonds, U.S. government bonds or notes, GNMA certificates and other mortgage-related securities, as well as cash.

American Funds Mortgage Fund

- The fund's investment objective is to provide current income and preservation of capital.
- Focuses on high-quality residential and commercial mortgage-backed securities that are either guaranteed or sponsored by the U.S. government.
- Normally, at least 80% of the fund's assets will be invested in mortgage-related securities. Up to 10% of assets may be invested in high-quality, U.S. dollar-denominated mortgage-related securities from issuers outside the U.S.

Capital Income Builder

- The fund has two primary investment objectives. It seeks (1) to provide a level of current income that exceeds the average yield on U.S. stocks generally and (2) to provide a growing stream of income over the years. The fund's secondary objective is to provide growth of capital.
- The fund's globally diversified strategy focuses on prudently generating a growing stream of income that exceeds the yield paid by U.S. companies in general. Its flexible equity income strategy uses a mix of stocks and bonds in pursuit of the fund's income objective.
- Normally, at least 50% of assets will be invested in common stocks of large, established companies with proven records of increasing dividends. May also invest in preferred stocks, convertibles, bonds and cash.

American Mutual Fund

- The fund strives for the balanced accomplishment of three objectives: current income, growth of capital and conservation of principal.
- The fund is conservatively managed to reduce volatility and risk. It does not invest in companies that derive the majority of their revenues from tobacco and/or alcohol.
- The fund invests primarily in common stocks, securities convertible into common stocks, nonconvertible preferred stocks, U.S. government securities, investment-grade (Baa/BBB and above, or unrated, but determined by the fund's investment adviser to be of equivalent quality) bonds and cash.

*Cash and equivalents includes short-term securities, accrued income and other assets less liabilities. It may also include investments in money market or similar funds managed by the investment adviser or its affiliates that are not offered to the public.

Investment professionals continue to manage each fund for 30 years after it reaches its target date. Although the target date funds are managed for investors on a projected retirement date time frame, the fund's allocation strategy does not guarantee that investors' retirement goals will be met.
