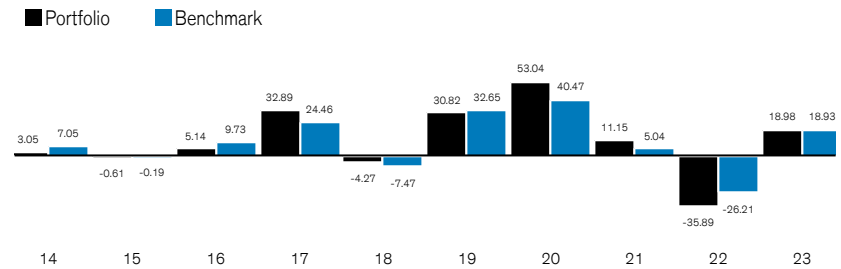

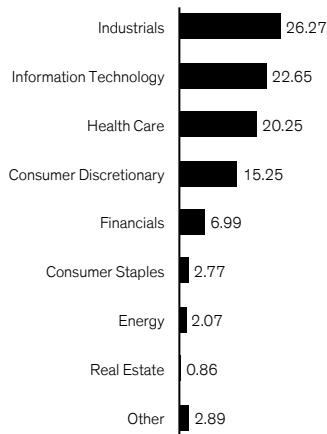
Annual Performance: Total Return - Z, Net (%)
